



# Upcoming Events

House Bill 5 is now heading to the State Senate: The bill, known as the Safer Kentucky Act, passed in the House. VOCAL-KY and allies continue to oppose HB5 and call it for what it is the "Unsafe Kentucky Act". This bill neglects the root causes of crime and focuses on increased spending on incarceration. It's possible HB5 won't be heard in Senate Judiciary Committee until March 7th at the earliest

- HB 5 will easily cost Kentucky more than \*\$1 billion\* over a decade just from limited provisions for which data could be obtained through corrections, impact statements and open records requests.

# Month in Review

**"We Love Voting Rights" Lobby Day and Rally**: The people mobilized in Frankfort at the capitol on February 13th to restore voting rights to Kentuckians with felonies in their past. We gather in the rotunda for a rally led by people directly impacted by this issue, telling their stories.

**Amnesty Dockets:** VOCAL-KY joined with allies on Feb. 9, 10 and 12th, in Jefferson County District Court. The amnesty dockets followed an effort by the The Coalition to End Jail Deaths, County Attorney, District Court Judges and the office of the Circuit Court Clerk to dismiss bench warrants five years old or more that meet these same criteria in the wake of the COVID-19 pandemic. It gave many people the opportunity to resolve old court cases, fines and fees without being arrested. It was a great opportunity to prevent unnecessary incarceration and restore hope in the judicial process. We had a great turnout out. VOCAL-KY was very happy to assist with Court reminders, transportation, lunch and court support all three days with our community partners.

**Black Lobby Day:** Allies joined together for grassroots lobbying in Kentucky. We gathered at the Kentucky State Capitol on **Monday February 26th**. Topics ranged from reparations, death penalty, education and black history.

**Smart Justice Mini Lobby Day:** On **February 28**, we joined together with ACLU of Kentucky for the Smart Justice Lobby Day! Leaders had the opportunity to talk to their legislators about Clean Slate legislation, Liberation Identification legislation, and why harsher punishments don't deter or address the root of crime.

**Rally for a New Kentucky:** Students in Kentucky are under attack! The 2024 General Session has seen bills restricting students -- and their communities -- rights to voting, learning about BIPOC history and inclusive, holistic care. February 29, was an event of solidarity with Kentuckians for the Commonwealth.
